



Lesson & Training Contract

This agreement is made _____ (date), between Reverie Equestrian, represented by Brittany Lowe (Hereinafter "Trainer") and _____ (Hereinafter "Owner"). Whereas, Owner is the legal owner or lessee of the horse described below and desires to have the horse trained. Trainer is a horse trainer, and agrees to train said horses. In consideration of the agreement herein set forth, the parties agree to the following terms:

1. Description of Horse:

2. Lesson/Training Package Fee: Due and payable upon the first of the month. In the event said payment is overdue by five (5) days, Owner is subject to a \$15.00 late fee. In the event said payment is overdue by ten (10) days, Owners is subject to a second \$25.00 late fee.

Training Fee: (check type)

(Training sessions are to be 30 minutes to one hour depending on the training session format and horse experience level and stamina.) The **full training** package is interchangeable with lessons(allowable up to 3 lessons per week with the full training package, 2 jumping lessons and 1 flat lessons.) These prices are available at discounted rates to encourage more riders and horses to be committed to consistency which in turn yields greater success at a faster rate. Lessons are offered Tuesday thru Friday 8am to 7pm and Saturday's 8am to 3pm.

_____ Full Training - 4-5 training sessions per week = \$600.00/month (up to 12 lessons)

_____ Individually Billed Training Session - \$60.00 per session

- Billed monthly if boarding a horse
- Due upon training session if not boarding a horse

3. Trainer's Duties: Trainer shall train and care for horse, in a manner consistent with accepted equine practices. Trainer has the discretion to decide what method/style of training and equipment is appropriate, based on the specific horse and intentions of the Owner.



4. Expenses: Owner shall bear the cost of transportation to and from the Trainer's facility, and all boarding, horse feed, veterinary and farrier fees. Owner is responsible for procuring any and all insurance to protect Owner from losses of any type to the Owner's horse.

5. Showing of Horse: Unless specifically advised by the Owner not to exhibit said horse, Trainer shall, at Trainer's and Owner's discretion, have the horse shown at the horse shows of his/her choice. Trainer shall provide any necessary transportation to and from said show at the rates stated below. In the event professional horse transportation services are utilized, Owner agrees to pay all said applicable charges. Owner shall pay for any and all entry fees, ground fees, stall and bedding fees, or other related charges incurred while horse is being shown or transported, including any and all lay-up charges in transit. Owner agrees to the show costs stated below. Owner/ Lessee shall receive all trophies and ribbons. Owner/ Lessee shall receive 100% of all money earnings.

Away Show Fees to Reverie Equestrian:

- Full Daycare - \$35.00/ day
 - Stall cleaning, Feeding & Watering
 - Grooming, Tacking, Bathing, Wrapping & Un-braiding
- Partial Daycare - \$20/ day (Stall cleaning, Feeding & Watering)
- Schooling Professional Ride - \$50.00/ Ride (NC to horses in full training program)
- Show Professional Ride - \$25.00/ class shown
- Show Schooling Lesson - \$60.00/ lesson (NC to horses in full training program)
- Show Coaching - \$65.00/ day the client rides in show per horse (\$100/ day if less than 3 horses attending the horse show that's further than 1 hour away)
- Lunging - \$15.00/ day
- Tack Trunk Packing & Unpacking - \$10.00/ show
- Show Set-up & Take-down - \$10.00/ show
- Tack Trunk Rental: \$20.00/ show
- Reverie Owned Horse Lease Fee: \$50.00/ day
- Trainer and groom travel expenses to be split evenly amongst number of horses at show
 - Staff Hotel/ Lodging Expense - at cost per show split evenly amongst number of horses or Trainer Camper Lodging - \$75 per night when available split evenly amongst number of horses
 - Staff Gas Expense - at cost per show split evenly amongst number of horses
 - Staff Flight Expense - at cost per show split evenly amongst number of horses
 - Staff Food Expense - \$35/ day/ staff member split evenly amongst number of horses
- Hauling Long Distance (over 75 miles) - \$1.00/ mile
 - Tyler - \$125 one way/ \$250 Round Trip
 - Waco - \$145 one way/ \$290 Round Trip
 - Katy - \$300 one way/ \$600 Round Trip
- Hauling Locally (under 75 miles round trip) - \$75 minimum

1-Day Haul-in Show Fees to Reverie Equestrian:

- Schooling Professional Ride - \$50.00/ Ride (NC to horses in full training program)
- Show Professional Ride - \$25.00/ class shown
- Show Schooling Lesson - \$60.00/ lesson (NC to horses in full training program)



- Show Coaching - \$65.00/ day the client rides in show per horse
- Lunging - \$15.00/ day
- Hauling Locally (under 75 miles round trip) - \$75 minimum
- Tack-up/ Grooming Fee - \$15

Non-client Horse Show Fees to Reverie Equestrian:

- Coaching Fee- \$75.00/ day
- Training Ride - \$60.00/ ride
- Professional Ride - \$30.00/ class
- Lunge - \$15.00

6. Horses out of Training: If, during this agreement, Owner's horse is taken out of training due to injury, Owner shall pay the cost of feeding, veterinary services and medicines, and transportation in maintaining any such horse, but shall not pay for training while horse is impaired. Trainer shall notify Owner as soon as it is known that the horse needs to be removed from training and when its training commences again. If Trainer must tend to injured horse, it is not included in the training price; owner shall pay for any wound care, handwalking, medications, rehab riding or special care needs separately.

7. Horse Sales: If horse is sold while in training or under the guidance of Trainer, a commission of 15% of the gross sales price of horse is due to Trainer. If Owner enlists Trainer's assistance in the sale of horse(s) that is/are in training or under the guidance of Trainer, Owner may opt to pay the standard 15% commission, or he/she may state the bottom dollar he/she will accept for the horse and pay Trainer any money in addition to this amount received in the sale of the horse. If Owner consigns horse to an auction or catalog sale while in training or under the guidance of Trainer, Owner agrees to pay Trainer 5% of the gross sales price of horse. Trainer may bill Owner, in addition to regular training fees, for the production of a sale video as well as any other miscellaneous services provided (such as, but not limited to bathing, clipping, and banding) if Owner intends to sell horse(s) without paying a commission to Trainer.

7. Risk of Loss & Indemnification: Trainer shall not be liable for accident, injury, disease, theft or death of any horse while in Trainer's custody. Owner agrees to defend, indemnify and hold harmless Trainer and/or affiliates, such as, but not limited to Brittany Lowe, Reverie Equestrian, and the property owners, to the fullest extent permitted under Texas law, from all liability or claims, actions, costs and/or damages, arising out of training Owner's/Lessee's horse.

8. Health Requirements & Coggins Test: The owner is to provide a Coggins test with negative results, prior to unloading the horse at Trainer's facility. The Coggins test must have been performed within the last twelve months. The owner must also provide a Health Certificate by a licensed veterinarian, attesting that said horse is free of infectious or communicable disease. The owner must provide a health record, including immunization and worming records.

9. Amendment of Agreement: This agreement may be amended at any time by both parties, and the amendment must be initialed by both parties.



10. Guarantee or warranty: Client understands that Trainer offers no guarantee or warranty of any kind regarding Trainer's services. In particular, Client understands that while Trainer will develop a training program for Horse designed to meet Client's goals, Trainer can offer no guarantee that Client's goals will be met within the time period that Client would like, or at all. Each horse is an individual and will progress at its own rate and according to its own talents and limitations.

11. Changes or Termination of This Agreement: It is agreed by the parties that this agreement may be changed or terminated by Trainer upon thirty (30) days notice, regardless of the rental or training period. All notices must be issued in writing unless otherwise agreed upon by the parties. The posting of updated rate schedules in a conspicuous or open place in Trainers office shall constitute notice of any and all rate changes or regulation changes as may be deemed appropriate by Trainer.
